**EASTERN CAPE  
LIQUOR BOARD**

- Every applicant for a liquor licence must consult the community within which she/he intends to operate a liquor outlet.
- The Ward Councillor responsible for the area concerned must convene a meeting with the community to discuss the application within 28 days from lodgement of application with the Eastern Cape Liquor Board.
- The Ward Councillor must submit a report to the Eastern Cape Liquor Board within 30 days from date of lodgment of application.
- The community can lodge written objections if they do not agree with the opening of a liquor outlet in their area.
- Where the proposed premises for the liquor outlet are within 100 meters from the church or school, such institution must be informed through submission of a form to the signed by church minister or chairperson of the school governing body / principal as acknowledgement of receipt of such notice. In the case of a school, there must be proof that a parents meeting was held to discuss this matter.
