



PROVINCIAL NOTICE BY THE MEMBER OF THE EXECUTIVE COUNCIL FOR THE DEPARTMENT OF ECONOMIC DEVELOPMENT, ENVIRONMENTAL AFFAIRS AND TOURISM

NOTICE IN TERMS OF SECTION 69 OF THE EASTERN CAPE LIQUOR ACT, 2003 (ACT NO. 10 of 2003) AND REGULATION 16 AND 17 OF THE EASTERN CAPE LIQUOR REGULATIONS, 2024.

DEFERRAL OF ANNUAL LICENCE RENEWAL PERIOD FROM 1 OCTOBER 2025 TO COMMENCE ON 1 DECEMBER 2025

I, Nonkqubela Pieters, Member of the Executive Council responsible for Economic Development, Environmental Affairs and Tourism in the province of the Eastern Cape in concurrence with the Member of the Executive Council responsible for Finance in the province of Eastern Cape, acting in terms of Section 69 of the Eastern Cape Liquor Act, 10 of 2003, hereby publish this notice in respect of the 2025 renewal period for liquor licence fees in accordance with Regulation 16 and 17 of the Eastern Cape Liquor Regulations, 2024.

The annual renewal period for all registered liquor licences, originally scheduled to commence on 1 October 2025, has been deferred. The renewal period for 2025 will commence on 1 December 2025.

This deferral is necessary to allow for the completion of the amendment process to the annual renewal licence fees, which are currently under review. The revised fee structure will be gazetted prior to the commencement of the 2025 renewal period

Licence holders are advised of the following payment timelines:

- 1 December 2025 to 28 February 2026: Renewal fees payable without penalties.
- 1 March 2026 to 31 March 2026: Renewal fees payable with a 50% penalty.
- 1 April 2026 to 31 August 2026: Renewal fees payable with a 100% penalty.

No renewal fees will be accepted after 31 August 2026, and the licence will be cancelled without further notice. Licence holders are further advised that no annual renewal payments will be accepted before 1 December 2025.
